1st FAI EUROPEAN OPEN INTERMEDIATE AEROBATIC CHAMPIONSHIPS DEVA 2021 ROMÂNIA

1. General

1.1. **Organizer**

- 1.1.1. The 1st FAI European Open Intermediate Aerobatic Championships 2021 will be organized by the Romanian Aeroclub and the Romanian Aeronautical Federation. It will take place under the auspices of FAI Fédération Aéronautique Internationale.
- 1.1.2. The operational organizer is the Romanian Aeroclub (B-dul Lascăr Catargiu, Nr. 54, sector 1, 010673, București).

1.2. Place and Date

- 1.2.1. The event will take place at Deva Airfield LRDV, located about 160 km southwest of Cluj-Napoca, and 400 km northwest of Bucharest which is the capital of the Romania.

- 1.2.5. The event will take place in the period of time: **July 4**th **to July 10**th **2021**.

1.3. Familiarization/Free Training Flights

- 1.3.1. Training flights at Deva airfield will be possible starting with June 30th 2021. The competition box will be marked for official training days.
- 1.3.2. Training at other airfields in Deva airfield vicinity is possible with previous agreement with Organizer. In case of need, please contact the Organizer at e-mail: info@eiac2021.ro or via the contact information in chapter 9.
- 1.3.3. Booking of slots for familiarization/official training will be available at the official contest website www.eiac2021.ro not later than **June 1**st **2021**.

1.4. Schedule

- 1.4.1. Official working hours of the Contest Office and Organizers will be from 08.00 until 18:00 or half an hour after the landing of the last competitor, whatever comes later.
- 1.4.2. The above mentioned hours are valid for official inquiries, information or claims/protest concerning the contest effective only for it's duration.
- 1.4.3. All stated times are in local time format (LT=UTC+3 hrs).
- 1.4.4. The Schedule may suffer modifications due to technical and organizational reasons or weather conditions.

2. Regulations

2.1. Rules

- 2.1.1. The 1st FAI European Open Intermediate Aerobatic Championships 2021 will be conducted according to the following rules:
 - FAI Sporting Code General Section,
 - FAI Sporting Code Section 6 Part 1,
 - Flight Rules published by the Civil Aviation Authorities of Romania,
 - Local Rules and Regulations (will be published during the Opening Briefing).

2.2. Official Language

2.2.1. The official languages during the EIAC 2021 are Romanian and English. The language of all communications and briefings is English.

3. Participation, Competitors and Aircrafts

3.1. Participants

- 3.1.1. All FAI member National Airsport Control's (NAC) may be represented at the 1st FAI European Open Intermediate Aerobatic Championships 2021 by the team and/or individual competitors/observers.
- 3.1.2. Entries will be accepted from NAC only according to FAI Sporting Code, Section 6 Part 1.
- 3.1.3. Each competitor must be a holder of:
 - a valid Pilot License with an aerobatic extension according to competitor's national legislation and contest category,
 - a valid FAI Sporting License,
 - a valid Medical certificate

3.2. Aircraft

- 3.2.1. All participating aircraft must satisfy the performance criteria essential for intermediate category competition flights.
- 3.2.2. For all competing aircraft a valid Certificate of Airworthiness of the related country must be presented with all other documents, which are required to being airworthy.

3.2.3. For all competing aircraft using the Romanian airspace, Third Party Liability insurance must be concluded with respect to damage caused by operation of that aircraft to third parties covering a minimum amount in SDR (Special Drawing Rights) or in equivalent value of any other freely convertible currencies, for the aircraft with MTOW as mentioned below:

• MTOW up to 1000 kg

1.500.000 SDR (approx. 1.800.000 EUR)

• MTOW above 1000 kg to 2700 kg

3.000.000 SDR (approx. 3.600.000 EUR)

- 3.2.4. Each competing aircraft must be insured against 3rd Party Public Liability, according to EU Regulation (EC) No. 785/2004, claims with a minimum amount as mentioned above according to MTOW. Aircraft arriving to the Romania must be able to present their insurance policy with a copy in English, certified by the Insurance Company.
- 3.2.5. All competing aircrafts must be equipped with VHF radio channel separation of 8,33 kHz according to Implementing Regulation (IR) 1079/2012 of European Commission valid from January 1st 2018.
- 3.2.6. The Technical Committee will check all the documents. Acceptance of the application will be decided considering these documents. The decision of Technical Committee will be final.
- 3.2.7. Several pilots can fly with one aircraft.
- 3.2.8. Limited hangar space for competing aircraft will be available for the duration of the Championship, free of charge.
- 3.2.9. In case of insufficient hangar capacity, priority will be given to those whose entry fee payment is confirmed by the Organizer, in order of confirmation. Priority will be given to aircraft of wooden construction, followed by composite and lastly metallic built.
- 3.2.10. Fuel AVGAS 100 LL & Oil AeroShell W100, AeroShell W120, 15W50 will be supplied by the Organizer.

4. Team Composition

4.1. Competitors

4.1.1. The Entries for competitors will be accepted from the NAC only according to FAI Sporting Code, Section 6 Part 1,1.2.4.1.

4.2. Other Team Members

4.2.1. Other team members, as defined in FAI Sporting Code, Section 6 Part 1, 1.2.6.2. may enter as National Team members. Entries will be accepted from the NAC only.

4.3. Observers

4.3.1. The relatives of competitors will be accepted as observers on National Team. The entry Fee

for observers is the same as for regular team members. Entries will be accepted from the NAC only.

5. Entries and Registration

5.1. Registration

- 5.1.1. Registration is available using the following means of communication:
 - Electronically using email send email to info@eiac2021.ro, registrations will be considered to be valid after confirmation from the Organizer;
 - Electronically using the information system found on the official website <u>www.eiac2021.ro</u>;
 - FAX use the telephone number provided in chapter 9;
 - Regular mail send your applications to the Romanian Aeroclub at the address specified in chapter 9.
- 5.1.2. Registration is valid and complete by submitting the Official Entry or the online registration form published on the official website with NAC confirmation sent by e-mail, FAX or regular mail.
- 5.1.3. In case of any problems with signup, registration or any other relevant issue, please contact the system administrator at info@eiac2021.ro.
- 5.1.4. Registration forms, electronic web form and other relevant informations will be available at the official contest website no later than 15th of March 2021.
- 5.1.5. **Registration deadline is 4th of July, 16:00 LT.**

5.2. Free Known sequence submission

- 5.2.1. The Free Known sequence of each competitor should be submitted not later than 4th of July, **16:00 LT** according to FAI Sporting Code, Section 6 Part 1, 2.2.1.9.a).
- 5.2.2. Competitors should provide their Free Known Programme as early as possible for checking, to avoid OSO issue (Organizer's Sequence Overload).
- 5.2.3. Competitors may submit their Free Known sequence to the e-mail address info@eiac2021.ro. Every submission will be confirmed. Sequence submissions are not valid without confirmation.
- 5.2.4. Free Known Programmes should be submitted using latest version of OpenAero or Microsoft Visio Aresti software file format.
- 5.2.5. Submission of the sequence must have / allow production of properly filled ABCRL form with all specific requirements stated in FAI Sporting Code, Section 6 Part 1, 2.2.1.9. Submission will not be accepted if these conditions will not be fulfilled.
- 5.2.6. No other format will be accepted (i.e. pdf, hardcopy or scanned hand-drawn).

6. Entry Fees

6.1. Entry Fees

6.1.1. Entry Fees are specified as follows:

• Competitor: 1800 EUR

- Other team members and observers: 1600 EUR
- 6.1.2. To pay the Entry fee please use the bank details provided in chapter 10.
- 6.1.3. The Entry Fee covers:
 - fuel and oil for competition flights;
 - shared accommodation double room;
 - breakfast, lunch and dinner;
 - transport between airfield and accommodation places;
 - official and social functions;
 - sanction fee of 160 euro per competitor;
 - programs arranged by the organizer.
- 6.1.4. A single room supplement of **20 EURO** applies **per night**.
- 6.1.5. Fuel and oil for all flights excepting competition flights will not be covered by the entry fee. The approximate current price for **1L of fuel is 2.5€** and for **1L of oil is 12.5€**, but the **prices might suffer changes**.

6.2. Accommodation and catering

- 6.2.1. Accommodation will take place in three star / four star standard hotels in the town center of Deva within 5 km of the airfield, 10/15 minutes by car.
- 6.2.2. Accommodation for Competitors and other Team members will be covered by the Organizer from July 4th until July 11th (7 nights).
- 6.2.3. Three meals per day and refreshments for all participants will be arranged by the Organizer. Breakfast will be provided by hotel. Lunch and dinner will be provided at the contest site.
- 6.2.4. Meals for Competitors and Team members will be provided from **July 4th (dinner)** until **July 11th (breakfast)**.
- 6.2.5. In case of special needs regarding accommodation or catering, please contact the Organizer using e-mail info@eiac2021.ro or other contact information in chapter 9 of this document.

6.3. Deadline for the Entries

6.3.1. The **Preliminary Entry Forms** should be provided to the Organizer no later than **May 31**st **2021**.

- 6.3.2. The **Official Entry Forms** as well as the **Entry Fees** must be provided to the Organizer no later than **June 21**st **2021** according to FAI Sporting Code, Section 6 Part 1, 1.4.1.2.
- 6.3.3. If payment is made later or at the contest site, an additional **EUR 150** will be charged.
- 6.3.4. Any participant wishing to query the arrival and clearance of their fees should contact the Organizer using e-mail info@eiac2021.ro.
- 6.3.5. Entry Fee must be paid in full amount and bank fees must be charged to sender's account.

6.4. Entry Fee Refund Policy

- 6.4.1. If a registered competitor or official has to withdraw from the competition, his/her NAC may substitute another pilot or official with no financial penalty. If a participant wishes to cancel their entry, the NAC representative must contact the Organizer. The date of withdrawal will be noted by the Organizer and will set the proportion of the fee to be refunded by the Organizer.
- 6.4.2. Depending on the Covid19 situation in Romania and in Europe, we decided that **June 7**th will be the **GO/NO GO** date of the competition. If there will be a NO GO, **all fees will be refunded**.
- 6.4.3. If the number of competitors is **less than 15 from 5 countries**, we will try to organize the event as a **national competition** but with less international officials, in which case we will refund the entry fee if the participant will no longer wish to take part in the competition.
- 6.4.4. In case of competition being cancelled or a participant not being able to compete due to **Covid19 100%** of the entry fee would be refunded.
- 6.4.5. In the case of entry fee refunds the refunded amount will be reduced by any bank fees that apply to the Organizer.
- 6.4.6. If a competitor is disqualified from the event according to FAI Sporting Code, Section 6 part 1, no entry fee will be refunded.

7. Protests

7.1. Protest Fee

7.1.1. Protest must be submitted accompanied by the payment of **100 EUR**.



12. How to get to Deva airfield

- 12.1.1. Deva airfield is located about 6 km east from the town DEVA.
- 12.1.2. To get to the airfield:
 - by air: there are several entry points in Romania

o On the west: LRSM – Airport Satu Mare

LROD – Airport Oradea LRAR – Airport Arad


LRTR – Airport Timișoara

On the north-east: LRSV – Airport Suceava

LRIS – Airport Iași

Note: It is mandatory to land first in an International Airport for customs.

- by train: all the trains which passing DEVA (Hunedoara). After arriving in Deva, a car will pick you from the train station. Please inform the organizer about your estimated time of arrival.
- by car: after exiting the town DEVA in the direction Sibiu, after passing Santuhalm, on the left side will see a company named DHS. After the company DHS, turn left and in a few hundred meters, you will arrive to the airfield. (see map below).
