**Note:** This schedule may be altered due to technical and organizational reasons as well as weather conditions.

# 5. Training Flights

5.1. They are provided on the site of the contest from 3th to the 8th September.

A schedule will have to be filled in on the website of the contest <a href="www.eac2023.it">www.eac2023.it</a>. Each pilot must select an available slot for a training flight between 9.00 until 19.00. In case of bad weather conditions, both the Flight Director (FD) and the pilot will agree on another slot. The FD can modify the order of the training flight.

#### 6. Accommodation

6.1. Accommodation will be booked by Organisation in high standard hotels in the center of City of Pavullo (10 minutes walk from the airport, 5 minutes by car)

- 6.2. Entry fee includes 9 nights from September 8th (check in) until 17th September in the morning (check-out) in a Double room. Extra fee of 20 Euros par days for a single room.
- 6.3. Teams or pilots **arriving earlier** will have to pay their accommodation fuel and oil comsumption. Organisation can provided to hotel reservation and meals at 150 euros each days.
- 6.4. Shuttles between hotels and airfield will be provided by our sponsor from 8th to 17th September
- 6.5. Accommodation: High standards hotel

# 7. Entry Eligibility

- 7.1. All the entries will be accepted according to the FAI Sporting Code, section 6 chapter 1.2.4 and 1.2.5
- 7.2. The entries for competitors will be accepted through the National Airsports Control (NACs) according to the FAI Sporting Code, Section 6, 1.2.4. and 1.2.5.
- 7.3. Other team members, as defined in the FAI Sporting Code, Section 6 Part 1, and 1.2.6) may enter as National team members. Entries are only accepted through the NAC controls.
- 7.4. Admission of observers of National team is accepted (1.2.6). The entry fee for observers is the same as for non-competitor team members. Entries are only accepted through the NACs (1.2.6).
- 7.5. The organizers accept entrants "Hors concours" (H/C) according to Sporting Code, section 6, 1.2.6., as long as they can provide evidence of appropriate and current Unlimited level experience.
- 7.6. The organizers may limit the number of H/C entrants depending on the number of NAC competitors at the Championships. Priority given to H/C will be based on the date of reception of the valid entry form and the fully paid entry fee.
- 7.7. Registration will be valid and complete only after the submitted Official Entry forms are validated, and the full entry fees paid.
- 7.8. Online and registration paper form and other relevant information will be available on the official contest website. **Pre-registration form is available on website** <a href="www.eac2023.it">www.eac2023.it</a> and can be submitted in advance to facilitate coordination.

#### 8. Pilot

- 8.1. Pilot entry requirements
  - Valid EASA pilot license for flight aerobatics or ICAO compliance
  - Valid pilot medical certificate
  - Valid FAI Sporting License
  - Valid personal insurance policy

#### 9. Aircraft

- 9.1. Each aircraft participating in the competition must have a valid Certificate of Airworthiness for unlimited aerobatics. A valid aerobatic certificate of airworthiness or equivalent document issued by the competent aviation authority of the participant's country must be produced to the organizers for every contest aircraft. (FAI Sporting Code 1.2.7)
- 9.2. Aircraft of experimental category must have an Easa permit to fly. Overfly, take off and landing in the italian airspace is allowed for 28 consecutives days.

#### 10. Insurance

- 10.1. All aircraft using the Italian airspace must be insured for the liability of damages caused by operation of the aircraft to third parties in compliance with the conditions of the Regulation (EC) No 785/2004 of 21/08/2004 covering a minimum amount in SDR (Special Drawing Rights) according with the following MTOW:
- Up to 1000 kg 1.500.000 SDR (approx. 1.900.000 €)
- 10.2. Each aircraft must have a Certificate of Insurance for use in an aerobatic FAI competition

# 11. Entry Fee:

- 11.1. Competitors (double bed room): 2 840 €
- 11.2. Team members and observers (double bed room): 1 900 €
- 11.3. Additional charged for single room: **20 € par Day**
- 11.4. The entry fee covers:

Accommodation from 8th (check in) till 17th of September (9 nights),

3 meals a day (breakfast, lunch and dinner)

AVGAS 100LL and Oil for the competition flights (D100 or 15W50)

Transfers between hotel and airfield

Opening and Closing ceremonies (including meals)

Entertainments provided by the organizer

Entry fee must be paid before June 1st. After June 1st an additional charge

#### 11.5 Deadlines

Entry fee must be paid in full within June 1st. See the table below for late and very late payment

- 11.5.1. If the organizers cancel the EAC 2023 before 15th June the whole entry fee will be refunded. After 15th July all unspent EAC funds will be used to repay as much of the entry as possible with priority given to participants who have been the first ones to pay their entry fees.
- 11.5.2. If a registered pilot or official has to cancel his participation, his NAC can substitute another pilot or official with no financial penalty. If a participant cancels his entry, through the NAC information, the proportion of the fee will be refunded as explained below:

Before June 1st: 100% refund

From June 1st until July 1st: 50% refund

After **July 1st**: no refund

#### 12. Free Sequence Submission

- 12.1. According to the FAI Sporting Code, Section 6, Part 1, 2.2.d) the Free sequence of each competitor is submitted not earlier than **8th August** to the contest organizer and not later than **7st September**(14.00 LT) on the contest site.
- 12.2. Competitors have to submit their free Known sequence (Programme 1) to the e-mail address of the organizers for checking and confirmation for validation.
- 12.3. Free sequences are submitted using OpenAero drawing software (seq format). Sequence must be drawn using the latest available software version. The computer file must contain completed pages for the three forms (A, B and C).

# **13. Anti-Doping Policy**

- 13.1. All pilots participating to the contest may be subject to an anti-doping control instructed by the world anti-doping agency.

#### 14. Protest Fee

14.1. Protest can be submitted by paying 90 €.

#### 15. Other cost
