

## Organiser

The 32<sup>nd</sup> FAI World Aerobatic Championships and the 1<sup>st</sup> Open Excellence Aerobatic Challenge are organised by the Aero Club of Zamosc, the member of the Aero Club of Poland.

## Programmes

### Unlimited Cat I

The 32<sup>nd</sup> FAI World Aerobatic Championships are a Category I Event, open to Unlimited Pilots. The proper Titles and Medals will be awarded according to provision 6.5.5.1 of FAI Sporting Code, Section 6 Part 1.

#### Excellence Challenge

The 1<sup>st</sup> Open Excellence Aerobatic Challenge is opened to all Pilots with the appropriate level of training. The proper Titles of Winners of the Championships will be awarded with Medals provided by the Organiser.

## REGULATIONS

### Unlimited Cat I

The 32<sup>nd</sup> FAI World Aerobatic Championships are organised in accordance with the following rules:

- FAI Sporting Code General Section;
- FAI Sporting Code, Section 6 Part 1;
- Flight Rules published by the Civil Aviation Authorities of Poland;
- Local Regulations.

#### Excellence Challenge

The 1<sup>st</sup> Open Excellence Aerobatic Challenge is organised in accordance with the following rules:

- FAI Sporting Code General Section;
- Sporting Code Open Excellence Aerobatic Challenge;
- Flight Rules published by the Civil Aviation Authorities of Poland;
- Local Regulations.

## Observers

- The Relatives of Competitors are accepted as Observers of the National Teams;
- The Entry Fee for Observers is the same as for the regular Team Members.

## PARTICIPATION, COMPETITORS AND AIRCRAFT

### Participants

- All Members of FAI NACs may be represented at the WAC 2024 via their Teams and/or an individual Competitor/Observer;
- Entries (including H/C pilots) may be submitted by NACs authorised Representatives only, with the exception of FAI Applicants from countries without a NAC.

## Competitors

Each Competitor should be a holder of:

- A valid Pilot Licence with an aerobatic extension according to a given Competitor's national legislation;
- A valid FAI Sporting Licence;
- A valid Medical Certificate;
- A valid Personal Insurance Policy.

## Aircraft

- All participating Aircraft must satisfy the performance criteria essential for the Competition Flights in Unlimited and Excellence Challenge;
- For all competing Aircraft, a valid Certificate of Airworthiness of the related country must be presented;
- For all competing Aircraft using the airspace of the Republic of Poland, Liability Insurance must be concluded with respect to damage caused by operation of the Aircraft to third parties covering a minimum amount in SDR (Special Drawing Rights) or in equivalent;
- Value of any other freely convertible currencies, for the Aircraft with MTOW as mentioned below:

## MTOW up to 1000 kg - SDR 1.500.000 (approx. EUR 1.800.000)

### MTOW above 1000 kg to 2700 kg - 3.000.000 SDR (approx. EUR 3.600.000);

 Each competing Aircraft must be insured against 3rd Party Public Liability, according to EU Regulation (EC) No. 785/2004, claims with a minimum amount as mentioned above according to MTOW. Any person legally responsible for a given Aircraft arriving

to the Republic of Poland, must be able to present their Insurance Policy with a copy in English, certified by the Insurance Company;

- All competing Aircraft must be equipped with VHF radio channel separation of 8.33kHz according to Implementing Regulation (IR) 1079/2012 of the European Commission valid from 1st January 2018;
- In case of insufficient hangar capacity, the priority will be determined by the Organiser. In case of doubt, the order of received Entry Fee payment dates will be taken into account.

## ARRIVALS AND LOGISTICS

- The Organiser requires the Participants to announce their expected arrival date to coordinate the Aerodrome operations and aircraft storage;
- The Organiser offers to arrange accommodation in hotels for the duration of the Championships and Training Days (if requested).

## SAFETY

- Due to the war in Ukraine, some military activities may occur (see Notam in Appendix);
- The Organiser remains in close contact with the Polish Military Authorities that support the WAC in Zamosc and will facilitate the access to the Aerodrome;
- The Polish territory is a sovereign country, and Poland is a NATO Member;
- If for any reason the geopolitical situation is getting worse, the Organiser will immediately inform the NACs. Regular updates will be posted on the Contest's Website;





Rzeszow Jesionka – Zamosc




