14th FAI WORLD ADVANCED AEROBATIC CHAMPIONSHIP

1. Introduction

After a thorough examination of the current pandemic situation and forecast for the coming months, Organizers decide to **GO** with the Championship. This means that Organizer considers the risk of not being able to hold the event and to have a low number of participants as minimal or insignificant.

We still of course expect specific conditions that will have to be adopted during the pre-event (official training days) and event operations. More information will be provided on the contest website <u>waac2021.cz/covid19-measures</u>.

Even though the current situation and forecast related to the spreading of coronavirus COVID19 look very positive, we understand the concerns of some competitors leading to late registration or cancelation of participation. To encourage those hesitating to decide whether to participate or not we would like to offer a modified schema of Special Entries and related deadlines. Please understand that we are in an unprecedented situation which never happened before. Late entries will be possible, but we are then unable to guarantee to provide a full-scale of services (accommodation). It is impossible to arrange accommodation for large groups of participants late. However, small groups of individual teams would be able to find suitable accommodation and the organizer will provide maximum support to arrange a booking for them.

The organizer would like to thank the pre-registered participants. A list of currently registered participants is available at the contest website <u>waac2021.cz/participants-list</u>. This indication of participation helped us with the "GO" decision significantly.

2. Regular Entries

2.1. **Regular Entry Fee**

- 2.1.1. Regular Entries will be handled as stated in Bulletin No. 1.
- 2.1.2. Regular Entry Fees are specified as follows:

•	Competitor:	EUR 1800
•	Other team members and observers:	EUR 1600

- 2.1.3. The Entry Fee covers:
 - accommodation during the Championship as in paragraph 2.1.6.,
 - three meals per day as specified in Bulletin No. 1,
 - fuel and oil for competition flights,
 - official and social functions,
 - program arranged by the Organizer,
 - the CIVA Sanction Fee 160 EUR per pilot.
- 2.1.4. A single room will be charged an additional fee of **200 EUR**.
- 2.1.5. The Official Entry Forms, as well as the Regular Entry Fees, must be provided to the Organizer not later than **June 9th**, **2021** (postponed to 5 weeks prior to the Opening Briefing).
- 2.1.6. The Organizer will cover accommodation for Competitors and other Team members from **July 14**th to **July 25**th (11 nights).

2.1.8. Regular Entry Fee return policy and late payment are modified as well and more details are provided in paragraph 2.3. of this document.

2.2. **Regular Entry Fee Payment and Deadlines**

- 2.2.1. The deadline for Entry Fee payment is **June 9th**, **2021**.
- 2.2.2. If payment is made **later than June 9th**, **2021**, an additional **EUR 300** will be charged.

2.3. Regular Entry Fee Refund Policy

- 2.3.1. If a registered competitor or official should withdraw, his/her NAC may substitute another pilot or official with no financial penalty. If a participant wishes to cancel their entry, the NAC representative must contact the Organizer. The date of withdrawal will be noted by the Organizer and will set the proportion of the fee to be refunded by the Organizer.
- 2.3.2. Withdrawal **before June 9th, 2021** 100% of the entry fee will be refunded.
- 2.3.3. Withdrawal **after June 9th**, **2021** 50% of the Entry Fee will be refunded.
- 2.3.4. In the case of Entry Fee refunds, the refunded amount will be reduced by any bank fees that apply on the Organizer side.

3. Special Entries

3.1. **Special Entry Fee**

- 3.1.1. Special Entry Fees are specified as follows:
 - Competitor: EUR 1200
 - Other team members and observers: **EUR 1000**
- 3.1.2. The Entry Fee covers:
 - three meals per day as specified in Bulletin No. 1,
 - fuel and oil for competition flights,
 - official and social functions,
 - program arranged by the Organizer,
 - the CIVA Sanction Fee 160 EUR per pilot.
- 3.1.3. The Official Entry Forms, as well as the Regular Entry Fees, must be provided to the Organizer not later than **July 9th**, **2021** (postponed to 6 days prior to the Opening Briefing).
- 3.1.4. **The Organizer will not cover accommodation expenses** and participants entering the championship by Special Entry are responsible for making the final arrangement of accommodation individually.
- 3.1.5. The Organizer will provide contacts to available hotels or will provide support with accommodation booking upon request.

- 3.1.6. Organizer is not able to guarantee transport between different hotels and airport for participants with Special Entry. Arrangement of a rental car can be provided upon request.
- 3.1.7. Special Entry Fees will not be refunded.

3.2. Special Entry Fee Payment and Deadlines

3.2.1. The deadline for Entry Fee payment is **July 9th**, **2021**.

4. Registration

- 4.1.1. Registration can be made using the following communication channels:
 - Ordinary mail send your applications to the address specified in part 5.1.
 - Electronically using email use email address <u>info@waac2021.cz</u> in which case registrations should be considered as valid after confirmation from the Organizer.
 - Electronically using the webform at website <u>waac2021.cz</u>. In this case, the confirmation letter from NAC needs to be uploaded.
- 4.1.2. Registration is valid and complete by submitting the Official Entry Forms or online registration form with NAC confirmation by mail, e-mail, or online AND by accepted payment at the bank account specified in part 6.1.1. Special Entry Fee can be paid in cash or by credit/debit card at the airfield.
- 4.1.3. Any participant wishing to query the arrival and clearance of their fees should contact the Organizer using e-mail <u>info@waac2021.cz</u> or the other contact information in part 5 of this document.
